

In-door Dog Park Acceptance of Risk and Release of Liability Form

Important information

The Pink Poodle is committed to providing programs and activities in a safe manner. We hold the safety of The Pink Poodle's Indoor Dog Park members, their guests and dogs in high regard. The Pink Poodle continuously strives to reduce risk and insists that all members and their guest follow safety rules and instructions that are designed to protect them. Persons who choose to enter The Pink Poodle's "In- door Dog Park" must understand there are inherent risks of injury and damage associated with off-leash dog parks.

You are responsible for determining if your dog is appropriate for an off-leash experience that may include many other dogs and people. We do not allow dogs with dangerous propensities, for example, biting or aggressive dogs, whether they be aggressive to people or other dogs. The Pink Poodle reserves the right to determine if a dog is aggressive.

VACCINATION REQUIRED

Rabies, Distemper/parvo and Bordetella. Certification from a veterinarian is required from each guest before admittance can be allowed. If your pet requires an updated vaccination, please make arrangements for the vaccination to be administered no less than 10 days before your visit to the Dog Park.

Canine influenza H3N8 and Canine influenza H3N2 is not a requirement but we highly recommend all dogs coming to the Dog Park receive this vaccination. Please consult your veterinarian to make the best decision for your beloved pet.

FLEA & TICK POLICY

All dogs should be flea and tick free. Dog Park guests with signs of fleas and ticks will not be permitted to check-in. Please consult your veterinarian for monthly flea and tick prevention prior to your visit at our park.

Warning of Risk

The Pink Poodle "In-door Dog Park" is intended to be an outlet for dogs and their owners to exercise, develop a stronger bond, and have a place for members to work with their dogs basic training and obedience if they choose. Despite all warnings, rules and precautions, certain dangers still exist. It is virtually impossible to predict all possible situations that could occur at an off-leash dog Park. Risk include serious personal injury and death to both humans and dogs, as well as damage to personal property, arising out of improper handling, supervision, or lack of control of a dog. Children are especially prone to injury or death from such things as bits and attacks since they sometimes demonstrate behavior that may seem threatening or prey-like to dogs. For example, yelling, screaming, quick movements, falling, and direct approaches to a dog can initiate a bite or attack, especially if the dog is unknown to the child. For safety purposes Minors must be 13 years of age or older to enter Dog Park. In this regard, it must be recognized that it is impossible for The Pink Poodle to guarantee the safety of members, their guests, and dogs. Each person who use The Pink Poodle Dog Park does so at his/her own risk and assumes the danger of using the Dog Park.

Waiver and Release of all Claims and Assumption of Risk

Please read this agreement carefully and be aware that entering the park, you will be expressly assuming the risk of injury and death to yourself, your children, and your dogs. As well as injury and damage to your property as a result of your use of the park, and that you will be assuming legal liability to others for any injury, death, damage to their property they suffer as a result of your use of the park. Additionally please be aware that you are releasing The Pink Poodle inc. from all Liability and claims for, death, damage to property and all other damage you, your child's, and your dogs might incur as a result of becoming a member of, and using, The Pink Poodle's "In-door Dog Park", and you are waiving any right to make or assert any claim against The Pink Poodle inc. for injury, death, or damage to you, your children, or your dogs as a result of your use of the dog park.

It is important that you know even if your dog is up to date on all of his/her vaccinations your pet can still get kennel cough and etc. The same way you can get a flu shot and still

catch "The Flu" and the same way kids in daycare can pass on "The Pink Eye" to one another, this also apply to dogs. The Pink Poodle is not responsible for transferring of kennel cough or any other upper respiratory infections.

Agreement to Waiver and Release of all Claims and Assumption of Risk
