

Doggy Daycare Rules, Regulations & Waiver

Vaccinations Required: Rabies, Distemper/Parvo virus & Bordetella. Please attach copy of your dog(s) current vaccinations. Tags are not accepted!

INJURIES & ILLNESS: First and foremost, the safety and well being of your pet(s) is of the highest importance. Ensuring that your pet remains safe and well cared for is our first responsibility and as such we take it very seriously. At the Pink Poodle Inc., we strive to provide your dog with excellent care and fun experience during their stay. Although dogs are always supervised, injuries can still occur while dogs are playing together such as scratches, cut or sprained joints. Such injuries are rare, but they happen at all daycares. In addition, while infrequent, dogs can get into fights, even under close supervision. Common areas for bites because of these fights are the snout, ears, tuft of the neck and paws. At the Pink Poodle Inc., we have procedures to screen dogs for aggressive behavior and we do not allow aggressive dogs to play with other dogs. However, even the friendliest of dogs get into a fight with extraordinarily little or no warning. In addition to injuries, it is possible for your dogs to transfer illness such as upper respiratory infections and kennel cough, even with the required vaccinations and boosters. This remarkably like a daycare for children where illness such as pink eye and flu can be transferred from one child to another. Such illnesses do not occur often, and all dogs must have necessary vaccinations to check-in.

AGE & GENDER: Dogs (5) months and older are allowed at The Pink Poodle inc. if they meet the facility's criteria of vaccinations. All dogs participating in doggie daycare must be spayed or neutered if over 6 months of age.

ABANDONMENT OF ANIMALS: I understand that if I do not pick up my dog by closing time (7:00pm), I will be charge an overnight fee of \$45/per dog. I understand that if I do not pick up 5days after the agreed upon pick up date, a certified letter will be sent regarding the animal abandonment. Should the animal not be removed within the specified time I, the client, hereby relinquish all claim to my animal, but shall not relieve me of contractual liability of any treatment, Boarding or care furnished.

PHOTOGRAPHS: I understand that photographs, video, or digital recordings are taken of the facility, pets, customers, and staff on a regular basis for, among other things, use in advertising by The Pink Poodle inc. I acknowledge that such images, together with prints and copyrights, therein are the property of The Pink Poodle. I give The Pink Poodle my consent, permission,

and authorization, without compensation to me, to use, reproduce, and alter the images, in print and electronic format (including the Internet), either alone or in compensation with other texts and graphics. I waive my right to approve the finish photograph, advertising copy, print material or electronic files that may be used in conjunction with images.

- 1.) I agree that The Pink Poodle inc. will not be liable for any claim's injury, illness, damage, or death to my dog during its stay and that under no circumstances will The Pink Poodle inc. be liable for consequential damages.
- 2.) I certify that I have informed The Pink Poodle inc. of all dogs and humans' aggression. I agree that I am responsible for any harm cause by my dog while in the care The Pink Poodle inc. I shall indemnity The Pink Poodle inc. against any claims made against it or for losses or damages suffered by The Pink Poodle inc. because of my dog.
- 3.) **MEDICAI RELEASE:** I understand that, in the event that a medical emergency arises while a pet is at our facility or participating in a service that we provide it is imperative that we are immediately able to get them medical treatment at the closest available facility. We will call ahead to veterinary offices in closest proximity geographically to us to insure they can handle the emergency present. Your pet will be rushed to the closest available facility for treatment and you will be notified. We notify the owner after we have secured medical treatment center for the animal to avoid delays that may be caused by emotion on the part of the owner. Our goal is to get your pet medical attention as quickly as humanly possible, and any distractions may interfere with that process. I agree that The Pink Poodle inc. May use its reasonable discretion in seeking veterinary care on my behalf and I will be responsible for all The Pink Poodle inc. related expenses. I authorize The Pink Poodle inc. to use the veterinarians if it is choice. I agree that the Pink Poodle inc. will not be liable for the actions and decision of the veterinarian. I also agree to be responsible for any reasonable fees assessed by The Pink Poodle inc. for emergency care and transportation.
- 4.) I authorize my veterinarian to share the medical records of my dog with The Pink Poodle inc. and other veterinarians. I assume full responsibility for payment of all veterinary services rendered, including, but not limited to diagnosis, treatment, necessary grooming, medical supplies, transportation, and boarding. I agree to make such payments directly to the attending veterinarian or reimburse The Pink Poodle inc. if direct payment cannot be made.

This agreement and waiver are valid from the date below and grants permission for future veterinary care without the need for additional authorization each time The Pink Poodle inc. cares for one or more of my dogs.
